Market Perspective. A down week, with the DOW down less than 0.1%; the S&P down 1.0%, and the NASDAQ down 3.2%. The sharp rise in interest rates, and especially the ten-year Treasuries, drove markets. Long term rates moved up more than short term rates, which steepened the yield curve, and the spread between the two and ten-year Treasuries. Not all stock moves made sense. Tech was down big, but it is not normally interest-rate sensitive. Bank stocks were up, which is expected with the steeper yield curve. Utility stocks, which are interest rate sensitive, moved up, not down, which was puzzling. The last time interest rates moved up sharply was in early February, followed by a terrible rest of the month for stocks. Let's talk about this rise in rates, and what it means.

Real Estate. I will give a third discussion of real estate investing, continuing from several month's ago. My talk will be "Al buys a rental townhouse." I will pretend buy an actual property and pretend rent it out. We will tour the townhouse using Zillow, finance it, look at the cash flow from renting it, tax deductions, and how it might play out over time.

Charitable Trusts. On <u>October 17</u>, John Woods will discuss charitable trusts, their tax advantages and flexibility of donations. We will also talk about Tax-Free Direct Charitable IRA Distributions, which the new tax law may make advantageous to some taxpayers.
