**Market Perspective. DOW 20,000!** The DOW finished the week above that level, and we know what that means. We will have our celebratory sheet cake sometime in the next few weeks, per Ed's decision.

Numerous article and have been written in the media, with charts depicting various milestones, and whether DOW 30,000 is likely anytime soon.

For the week, the DOW was up 1.3%; the S&P was up 1.0%; and the NASDAQ was up 1.9%. All are at or near record highs. The obvious question: is it time to get defensive?
