***Market Perspective.*** Mama said there'd be weeks like this! Pick you cliché. But we've been through this before. Right? Wednesday and Thursday were brutal, with frantic last half-hour selling, adding to miserable days. Some recovery on Friday. For the week, the DOW lost 4.2%; the S&P lost 4.1% - both over half their YTD gains; and the NASDAQ lost 3.7%. YTD, the averages are up 2.5%, 3.5%, and 8.6%. Drivers were the continued rise in interest rates, both short-term and long-term. Bond prices and stock prices both moved down, which is unusual. Bond prices (not yields) and stock prices normally move in opposite directions. Some have suggested a swing from momentum stocks (tech and the FAANGs) to value stocks.

By the time we meet on Wednesday, we should have some better insight of what is going on. What will happen on Monday and Tuesday? Earnings' season is upon us, and earnings are expected to be good and most economic indicators remain positive. The usual question: is it time to make adjustments in recognition of fundamental or longer term changes in markets?

Tom Crooker will comment on articles on the narrow range of the market prices this year.

Garrett Ruhl will comment on stock and bond rebalancing.

***Charitable Trusts Qualified Charitable Distributions (QCDs)*** John Woods will discuss charitable trusts, their tax advantages and flexibility of donations. We will also talk about Tax-Free Direct Charitable IRA Distributions, which the new tax law may make advantageous for taxpayers who previously itemized deductions, but will now take the standard deduction.
