**Markets.** Another mostly down week, the fourth straight. For the week, the DOW was down 1.8%; the S&P was down 0.6%; the NASDAQ was up 1.1%, and the small-cap Russell 2000 was down 4.0%. The FAAMGs had a big up week. The S&P is now down 7.8% from its all-time high on September 2. Once again, market direction is difficult to ascertain.

### **Topics this Week**

Panel Discussion. After the welcome and announcements, we will have a panel discussion each week of recent events impacting markets, or other topics of interest. Homebuilders. It's a sellers' market for homes, as you have probably noticed. Very few homes for sale, resale or new. Are the public homebuilders a good investment? I will look at the Consumer Discretionary/Cyclical sector (which includes the homebuilders), homebuilders' ETFs, and several of the larger national homebuilders.

Bob Baker will review the buys and sells.

### **Upcoming Topics**

Stock Selection. Sy Sherman gives Part 1 of his revised stock analysis class on October 7. This will be particularly useful to fund investors, or who rely on advisors, but who are thinking about buying individual stocks.

To Diversify, or Not. Most Forum members (I think) have diversified portfolios, either with funds, or 20 or more individual stocks - really a self-managed mutual fund, that is likely to track markets. They may "dollar cost average" - with smaller incremental buys over time. Others, though, buy a smaller number of stocks (10 or so) going all-in, a riskier strategy hoping their picks to "beat the market." The panel will meet during the Fall term.

Health Care sector. In the Fall, Tom Kaufman will discuss the health care sector, followed by Jim Dann looking at health care managed mutual funds.
