## <u>Markets</u>

A fairly smooth week, with the DOW up 0.7%; the S&P up 0.6%; the NASDAQ up 0.5%; and the Russell 2000 up 0.8%. The number of the week was 3, as in 3% inflation forecast from Treasury Secretary Yellen. Would that number cause the Fed to reduce its bond purchases, or raise short term rates?

## Topics This Week

<u>A global minimum corporate tax</u>. This tax, of 15% (and promoted by Ms. Yellen) has made surprising progress. Let's discuss this: what it is, how it will impact corporate behavior, and markets.

<u>Organon & Co. (OGN).</u> This company, with a market cap of \$9 billion, was unknown to most of us, until shares of it appeared in the brokerage accounts of all Merck shareholders on Thursday afternoon. Several have sold their shares. Who knows anything about OGN, and whether we should buy, sell, or hold?

<u>Energy Sector.</u> Energy (all kinds) has been the top performing sector YTD, after six years in the wilderness, during which time many of us exited energy. Is this real? Time to get back in? Too late? Is oil dead? Is "clean energy" the place to be?

<u>Capital Gains Exclusion on Sale of Primary Residence.</u> I am posting a copy of a <u>Wall Street Journal</u> article, "The Tax Break to Know in a Sellers' Market," on the Forum website. I am looking for somebody to walk us through it. The article is about the \$250,000 single, \$500,000 married couple, lifetime capital gains tax exclusion on sale of a principal residence. With the rise in housing prices, long time homeowners in high housing cost areas (looking at us) may have capital gains taxes on our homes. The exclusion is complicated, and above my pay grade.
