<u>Markets</u>

A down week, driven by the Fed's report on Wednesday afternoon, and which we discussed at last week's Forum. Concerns about inflation, and rate increases sooner than previously expected, along with talk of reduced bond buying, hammered markets. For the week, the DOW was down 3.5%; the S&P was down 1.9%; the NASDAQ was down 0.3%, and the Russell 2000 was down 4.2%. The yield curve flattened, with short term rates rising, and long term rates shrinking, hitting bank equities hard. Does this man markets are taking a breather (a pause that refreshes) before heading higher on the economic recovery and big growth ahead? Or something more troubling, like inflation?

<u>Capital Gains Exclusion on Sale of Primary Residence.</u> I have posted a copy of a <u>Wall Street Journal</u> article, "The Tax Break to Know in a Sellers' Market," on the Forum website. The article is about the \$250,000 single, \$500,000 married couple, lifetime capital gains tax exclusion on sale of a principal residence. With the rise in housing prices, long time homeowners in high housing cost areas (looking at us) may have capital gains taxes on our homes. The exclusion is complicated, and above my pay grade. Brenda Bloch-Young will go over the exclusion, at a date to be determined.
