New members of the Investment Forum, who did not introduce yourselves last week. And, if you wish, whether you pick your own investments, or use an advisor, whether you invest in individual stocks or funds, and why you joined us. All such participation is voluntary.

### Markets.

A good week, with the DOW up 1.1%; the S&P up 1.6%; the NASDAQ up 2.4%; and the Russell 2000 up 1.7%. Volatility continues, with huge moves, up and down, in some big names. (Own Amazon or Meta/ Facebook?) Earnings are coming in as expected, and some good jobs' numbers, are driving markets. Markets seem to have adjusted to expected Fed moves in 2022, including the possibility of a 1/2% (rather than 1/4%) rate hike in March.

Yield curve. I have restrained myself mentioning this for a while, but the 2-10 spread (difference between the 2 and 10 year Treasury bonds) has narrowed to 0.62%, and down from 1.6% last July. Most of the movement has been at the short end (the 2 year rate) which is anticipating the coming tightening of the Fed Funds rater. The longer term (10 year rate), which

has been mostly flat, will be impacted by the Fed "tapering" and selling off its \$9 trillion in bonds owned.

Topics this week.
