Markets.

TGIF. It was shaping up to be another really no good, lousy week, until Friday. Then some strong retail numbers; folks are still in the stores. For the week, the DOW was down 0.2%; the S&P was down 0.9%; the NASDAQ was down 1.6%; and the Russell 2000 was down 1.4%. Hardly stellar, but better than they were on Thursday. Inflation is still roaring; the Fed is still tightening (likely 0.75% or even 1.0% increase at the next meeting; and a recession is looming, or already here, if negative GDP in the second quarter. It is earnings' season. The big banks have posted profit declines, which were expected.

The yield curve is decidedly inverted, with the 2 year Treasury yielding 3.13% and the 10 year yielding 2.93%. This is a strong predictor of a recession. Or are we already in a recession?

Topics this week.

<u>The week that was</u>. We will lead off our discussions with recent market moves.

<u>Healthcare Sector.</u> Jim Dann will look at several funds in industries of Healthcare Sector, and find which has outperformed the others in recent years.
