(I continue to report the Dow Jones Industrial Average because it is so widely followed by the public, but it is a poor indicator of the current market because of its portfolio and nonsensical weighting.) Driving markets last week were Apple, and its ties to AI, tame inflation numbers, and the Fed meeting and comments. No rate change, but likelihood to two rate cuts in the rest of 2024.
