Markets.

A relatively quiet week, compared to recent weeks. The S&P was down 0.5%; the NASDAQ was down 0.3%; the Russel 2000 was up 0.1% Bitcoin was up 7.4% and gold was up 0.4%. Healthcare was the weakest sector, due to discussions of drug price controls. A trade deal with Great Britain was announced - low hanging fruit since the US has a trade surplus with the UK. Trade talks with China begin this week, which should be important, especially since shipments from China have dropped dramatically. Empty shelves ahead? And the Fed kept rates the same, citing worries policies causing inflation, slower jobs' growth, and economic stagnation. The President called Chair Powell "clueless."
